**Executive Order No. 105 of 5 August 2015 on certificates of competency and qualification requirements to manning on ships as amended by Executive Order No. 133 of 21 September 2017**

Under the provisions in section 10 subsection 1, section 11 subsection 1, section 12 subsections 1, 4 and 5, section 17 subsection 4, section 24 and section 25 subsection 1 in Parliamentary Act No. 63 of 3 July 1998 on manning of ships as amended by Parliamentary Act No. 31 of 19 May 2008, Parliamentary Act No. 75 of 25 May 2009, Parliamentary Act No. 71 of 30 May 2011 and Parliamentary Act No. 52 of 12 May 2015, the following shall be laid down:

**Chapter 1**

**Merchant ships**

*On service as a seafarer, motorman and ship's assistant*

**Section 1.** Seafarers who serve as ordinary seafarer, ordinary motorman or ordinary ship's assistant on seagoing merchant ships with a gross tonnage of 20 or above shall be 16 years of age and shall hold a valid health certificate for seafarers.

**Section 2.** Seafarers who serve as able seafarer, able motorman or able ship's assistant on seagoing merchant ships with a gross tonnage of 20 or above shall be 18 years of age and shall hold a valid health certificate for seafarers and either:

- 1) have completed 18 months seagoing service on seagoing ships with a gross tonnage of 20 or above,
- 2) have passed the basic training module for ship's assistant and have completed 12 months seagoing service on seagoing ships with a gross tonnage of 20 or above, or
- 3) have passed the ship's assistant training programme for persons holding a certificate of apprenticeship specialized in machinery or other relevant vocational education and training, and have completed 12 months seagoing service on seagoing ships with a gross tonnage of 20 or above.

**Section 3.** Seafarers who serve as able seafarer or able ship's assistant on seagoing merchant ships with a gross tonnage of 500 or above, shall before 1 January 2017 hold a certificate of proficiency as able seafarer or able ship's assistant.

*Subsection 2.* Seafarers who serve as able motorman or able ship's assistant on seagoing merchant ships with a propulsion power of 750 kW or above, shall before 1 January 2017 hold a certificate of proficiency as able motorman or able ship's assistant, respectively.

*Subsection 3.* Foreign seafarers who serve according to subsection 1 or 2 on ships registered in the Faroese International Ship Register, may hold a certificate of proficiency issued by the native country.

*Subsection 4.* The certificate of proficiency mentioned in subsection 3 is on the condition the IMO Maritime Safety Committee has stated that the certificate issuing country has, through its information material forwarded to the IMO, proven that it has fully and completely implemented the STCW Convention.

***On certificate of proficiency as ship's assistant on merchant ships - STCW Reg. II/5 and Reg. III/5***

**Section 4.** In order to acquire a certificate of proficiency as an able ship's assistant, the applicant shall be 18 years of age and shall

- 1) hold a health certificate for seafarers valid for the service for which the certificate of proficiency entitles the holder, including be fit for lookout duty,
- 2) meet the requirements for acquiring a watchkeeping certificate in accordance with the STCW Convention Reg. II/4 and III/4 and have passed either:
  - a) the final module for ship's assistant and have completed 18 months seagoing service, hereof 12 months deck service on seagoing ships with a gross tonnage of 20 or above and 6 months engine duty on seagoing ships with a propulsion power of 100 kW or above,
  - b) the final module for ship's assistant and have completed 12 months seagoing service, hereof 6 months deck service on seagoing ships with a gross tonnage of 20 or above and 6 months engine duty on seagoing ships with a propulsion power of 100 kW or above including an approved training record book, or
  - c) the ship's assistant training programme for persons holding a certificate of apprenticeship specialized in machinery, electrician or other relevant vocational

education and training, and have completed 12 months seagoing service hereof 6 months deck service on seagoing ships with a gross tonnage of 20 or above and 6 months engine duty on seagoing ships with a propulsion power of 100 kW or above

*Subsection 2.* 6 months of the approved deck service prescribed in subsection 1 No. 2, shall have been completed on merchant ships.

*Subsection 3.* Seafarers who have completed 12 months seagoing service on seagoing ships as able seafarer, able motorman or able ship's assistant between the period 1 January 2007 and 1 January 2012, are considered to comply with the requirements prescribed in subsection 1 No. 2.

***On certificate of proficiency as able seafarer on merchant ships - STCW Reg II/5***

**Section 5.** In order to acquire a certificate of proficiency as an able ship's assistant, the applicant shall be 18 years of age and shall

- 1) hold a health certificate for seafarers valid for the service for which the certificate of proficiency entitles the holder, including be fit for lookout duty,
- 2) meet the requirements for acquiring a watchkeeping certificate in accordance with the STCW Convention Reg. II/4 and have passed either:
  - a) the final module for ship's assistant and have completed 18 months deck service on seagoing ships with a gross tonnage of 20 or above or,
  - b) the final module for ship's assistant and have completed 12 months deck service on seagoing ships with a gross tonnage of 20 or above including an approved training record book.

*Subsection 2.* 6 months of the approved deck service prescribed in subsection 1 No. 2, shall have been completed on merchant ships.

*Subsection 3.* Seafarers who have completed 12 months seagoing service on seagoing ships as able seafarer between the period 1 January 2007 and 1 January 2012, are considered to comply with the requirements prescribed in subsection 1 No. 2.

***On certificate of proficiency as able motorman on merchant ships – STCW Reg. III/5***

**Section 6.** In order to acquire a certificate of proficiency as an able motorman, the applicant shall be 18 years of age and shall

- 1) hold a health certificate for seafarers valid for the service for which the certificate of proficiency entitles the holder,
- 2) meet the requirements for acquiring a watchkeeping certificate in accordance with the STCW Convention Reg. III/4 and have passed either:

- a) the final module for ship's assistant and have completed 12 months engine duty on seagoing ships with a propulsion power of 100 kW or above,
- b) the final module for ship's assistant and have completed 6 months engine duty on seagoing ships with a propulsion power of 100 kW or above including an approved training record book, or
- c) the ship's assistant training programme for persons holding a certificate of apprenticeship specialized in machinery, electrician or other relevant vocational education and training, and have completed 12 months engine duty on seagoing ships with a propulsion power of 100 kW or above.

*Subsection 2.* Seafarers who have completed 12 months seagoing service on seagoing ships as able motorman between the period 1 January 2007 and 1 January 2012, are considered to comply with the requirements prescribed in subsection 1 No. 2.

***Certificates of competency for masters and navigation officers on merchant vessels***

**Section 7.** In addition to the specific requirements for acquiring certificates of competency stated under the individual certificates, the applicant shall:

- 1) be of age and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act,
- 2) hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder, including be fit for lookout duty,
- 3) hold a valid certificate as a radio operator in GMDSS, GOC or ROC,
- 4) have passed the exam or test required for the issue of the certificate of competency within 5 years prior to the date of issue of the certificate of competency, and
- 5) if not otherwise stated, have completed the prescribed seagoing service on seagoing ships with a gross tonnage of 20 or above.

***Certificates of proficiency on merchant ships – STCW Reg. II/3***

**Section 8.** In order to acquire a certificate of proficiency on merchant ships, the applicant shall:

- 1) meet the requirements for acquiring a watchkeeping certificate for bridge watch in accordance with the STCW Convention Reg. II/4 and hold:
- 2) a certificate of proficiency in sailing and either have passed:
  - a) the basic training module for ship's assistant and have completed a total of 3 months seagoing service,
  - b) the ship's assistant training programme for persons holding a certificate of apprenticeship specialized in machinery, electrician or other relevant vocational education and training, and have completed a total of 3 months seagoing service, or
  - c) have completed a total of 12 months seagoing service.

*Subsection 2.* If the exam in competency in sailing is passed before 1 January 2015, a specific course established by the Ministry of education, research and culture is required, before the requirement in subsection 1 No. 2 is fulfilled.

***Mate 4<sup>th</sup> class on merchant ships – STCW Reg. II/3***

**Section 9.** In order to acquire a certificate of competency as mate 4<sup>th</sup> class on merchant ships, the applicant shall have passed the master (home trade) exam and either have passed:

- 1) the basic training module for ship's assistant, have completed 18 months seagoing service including an approved training record book,
- 2) the final module for ship's assistant, have completed 15 months seagoing service including an approved training record book, or
- 3) comply with the requirements as able seafarer, have completed a total of 12 months seagoing service as seafarer including an approved training record book, or
- 4) have completed 36 months seagoing service.

*Subsection 2.* 6 months of the approved seagoing service prescribed in subsection 1 shall have been completed on merchant ships.

***Master (home trade) on merchant ships – STCW Reg. II/3***

**Section 10.** In order to acquire a certificate of competency as mate (home trade) on merchant ships, the applicant shall be 20 years of age and shall:

- 1) hold a valid certificate of competency as mate 4<sup>th</sup> class on merchant ships,
- 2) be a Danish citizen and
- 3) have completed 12 months seagoing service under conditions where a certificate of competency as mate 4<sup>th</sup> on merchant ships, is prescribed.

***Mate 3<sup>th</sup> class on merchant ships – STCW Reg. II/I and II/2***

**Section 11.** In order to acquire a certificate of competency as mate 3<sup>th</sup> class on merchant ships, the applicant shall have passed the master exam, and either:

- 1) have passed the practical training as master and navigation officer under an approved training programme, have completed 12 months seagoing service including an approved training record book,
- 2) have passed the basic training module for ship's assistant, have completed 18 months seagoing service including an approved training record book,
- 3) have passed the final module for ship's assistant, have completed 15 months seagoing service including an approved training record book, or
- 4) comply with the requirements as able seafarer, have completed a total of 12 months seagoing service as seafarer including an approved training record book, or
- 5) have completed 36 months seagoing service.

*Subsection 2.* 12 months of the approved seagoing service prescribed in subsection 1, shall have been completed on seagoing ships with a gross tonnage of 500 or above. However, 6

months shall have been completed on merchant ships with a gross tonnage of 500 or above outside near-coastal voyages.

*Subsection 3.* Applicants who have passed the master exam and who meet the requirement stipulated in subsection 2, but have not completed seagoing service on merchant ships, may acquire a certificate of competency as mate 3<sup>rd</sup> class on merchant ships, with endorsement that the certificate of competency does not entitle the applicant to serve as chief mate.

*Subsection 4.* Applicants who have passed the master exam and who meet the requirement stipulated in subsection 2, but have not completed seagoing service outside near-coastal voyages may acquire a certificate of competency as mate 3<sup>rd</sup> class on merchant ships, with endorsement that the certificate of competency entitles the holder only to serve on ships in near-coastal voyages.

*Subsection 5.* Applicants, who have passed the master exam and who meet the requirement stipulated in subsection 2, but have not completed seagoing service on seagoing ships with a gross tonnage of 500 or above, may acquire a certificate of competency as mate 3<sup>rd</sup> class, with endorsement that the certificate of competency entitles the holder only to serve on ships with a gross tonnage below 500.

#### ***Master on merchant ships – STCW Reg. II/2***

**Section 12.** In order to acquire a certificate of competency as master on merchant ships, the applicant shall:

- 1) hold a valid certificate of competency as mate 3<sup>rd</sup> class on merchant ships,
- 2) be a Danish citizen and
- 3) have completed seagoing service under conditions where a certificate of competency as mate 3<sup>rd</sup> on merchant ships, is prescribed, in either
  - a) 24 months, 12 months of which as the chief officer or only mate, or
  - b) 36 months as mate.

#### ***Mate 2<sup>nd</sup> class on merchant ships – STCW Reg. II/2***

**Section 13.** In order to acquire a certificate of competency as mate 2<sup>nd</sup> class on merchant ships, the applicant shall have passed the master exam, and either:

- 1) have passed the practical training as master and navigation officer under an approved training programme, have completed 12 months seagoing service including an approved training record book,
- 2) have passed the basic training module for ship's assistant, have completed 18 months seagoing service including an approved training record book,
- 3) have passed the final module for ship's assistant, have completed 15 months seagoing service including an approved training record book, or
- 4) comply with the requirements as able seafarer, have completed a total of 12 months seagoing service as seafarer including an approved training record book, or

- 5) have completed 36 months seagoing service.

*Subsection 2.* 12 months of the approved seagoing service prescribed in subsection 1, shall have been completed on seagoing ships with a gross tonnage of 500 or above. However, 6 months shall have been completed on merchant ships with a gross tonnage of 500 or above outside near-coastal voyages.

### ***Mate 1<sup>st</sup> class on merchant ships – STCW Reg. II/2***

**Section 14.** In order to acquire a certificate of competency as mate 1<sup>st</sup> class on merchant ships, the applicant shall:

- 1) hold a valid certificate of competency as mate 2<sup>nd</sup> class, or
- 2) hold a valid certificate of competency as mate 3<sup>rd</sup> class and comply with the requirements to acquire a certificate of competency as mate 2<sup>nd</sup> class, and
- 3) have completed 12 months seagoing service on ships with a gross tonnage of 500 or more under conditions where a certificate of competency as mate 2<sup>nd</sup> or 3<sup>rd</sup> class on merchant ships, is prescribed.

### ***Master – STCW Reg. II/2***

**Section 15.** In order to acquire a certificate of competency as master on merchant ships, the applicant shall be a Danish citizen and either:

- 1) hold a valid certificate of competency as mate 1<sup>st</sup> or 2<sup>nd</sup> class, or
- 2) hold a valid certificate of competency as mate 3<sup>rd</sup> class and comply with the requirements to acquire a certificate of competency as mate 2<sup>nd</sup> class, and
- 3) have completed seagoing service on ships with a gross tonnage of 500 or more under conditions where a certificate of competency as mate 2<sup>nd</sup> or 3<sup>rd</sup> class on merchant ships, is prescribed in either
  - a) 24 months, 12 months of which as the chief officer or only mate, or
  - b) 36 months as mate.

## **Chapter 2**

### **Fishing vessels**

#### ***Ordinary seafarer and ordinary motorman***

**Section 16.** An ordinary seafarer or ordinary motorman shall be 16 years of age and shall hold:

- 1) a valid health certificate for seafarers, and
- 2) a valid basic safety training course for seafarers on fishing vessels in accordance with the STCW-F Convention Reg. III/I.

*Subsection 2.* Seafarers who have, before 29 September 2012, completed 12 months seagoing service on seagoing ships shall be exempted from the requirements stipulated in subsection 1, No. 2.

***Able seafarer and motorman***

**Section 17.** An able seafarer and able motorman shall be 16 years of age and shall hold:

- 1) a valid health certificate for seafarers, and
- 2) a valid basic safety training course for seafarers on fishing vessels in accordance with the STCW-F Convention Reg. III/I and either:
  - a) have completed 18 months deck service or engine duty, respectively, on seagoing ships,
  - b) have passed the basic training module for ship's assistant and have completed 12 months deck service or engine duty, respectively, on seagoing ships, or
  - c) hold a certificate of apprenticeship specialized in machinery, electrician or other relevant vocational education and training, and have completed 12 months service as ordinary motorman on seagoing ships.

*Subsection 2.* Seafarers who have, before 29 September 2012, completed 12 months seagoing service on seagoing ships shall be exempted from the requirements stipulated in subsection 1, No. 2.

***Certificates of competency for masters and navigation officers on fishing vessels with a length of 15 metres or above and scantlings of 100 or above***

**Section 18.** In addition to the specific requirements for acquiring certificates of competency stated under the individual certificates, the applicant shall be of age and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act and shall:

- 1) hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder, including be fit for lookout duty,
- 2) hold a valid certificate as a radio operator in GMDSS, GOC or ROC,
- 3) have passed the exam or test required for the issue of the certificate of competency within 5 years prior to the date of issue of the certificate of competency, and
- 4) if not otherwise stated, have completed the prescribed seagoing deck service on seagoing fishing vessels with a length of 12 metres or above and scantlings of 100 or above.

***Competency in sailing on fishing vessels***

**Section 19.** In order to acquire competency in sailing on fishing vessels, the applicant shall:

- 1) be a Danish citizen



- 2) have passed the test in competency in sailing, and either:
  - a) have passed the basic training module for ship's assistant and have completed 3 months seagoing service, or
  - b) have completed 12 months seagoing service.

*Subsection 2.* 6 months of the mentioned seagoing service prescribed in subsection 1, No. 2, paragraph b might have been completed on seagoing merchant ships with a gross tonnage of 20 or above.

*Subsection 3.* If the exam in competency in sailing is passed before 1 January 2015, a specific course established by the Ministry of education, research and culture is required, before the requirement in subsection 1 No. 2 is fulfilled.

#### ***Mate 4<sup>th</sup> class on fishing vessels – STCW-F Reg. II/4***

**Section 20.** In order to acquire a certificate of competency as mate 4<sup>th</sup> class on fishing vessels, the applicant shall have passed the master (home trade) exam and either:

- 1) have passed the basic training module for ship's assistant and either have completed 12 months seagoing service, or
- 2) have completed 24 months seagoing service.

*Subsection 2.* 12 months of the mentioned seagoing service prescribed in section 1, No. 2, might have been completed on seagoing merchant ships with a gross tonnage of 20 or above.

#### ***Master (home trade) on fishing vessels – STCW-F Reg. II/3***

**Section 21.** In order to acquire a certificate of competency as master (home trade) on fishing vessels, the applicant shall:

- 1) hold a valid certificate of competency as mate 4<sup>th</sup> class on fishing vessels,
- 2) be a Danish citizen, and
- 3) have completed 12 months seagoing service under conditions where a certificate of competency as mate 4<sup>th</sup> on fishing vessels or a competency in sailing fishing vessels, is prescribed.

*Subsection 2.* 6 months of the approved sea going service prescribed in subsection 1 No. 3, may be completed on seagoing merchant ships with a gross tonnage of 20 or above.

#### ***Mate 3<sup>rd</sup> class on fishing vessels – STCW-F Reg. II/2***

**Section 22.** In order to acquire a certificate of competency as mate 3<sup>rd</sup> class on fishing vessels, the applicant shall have passed the master exam and either:

- 1) have passed the basic training module for ship's assistant and have completed 12 months seagoing service, or
- 2) have completed 24 months seagoing service.

*Subsection 2.* 12 months of the mentioned seagoing service prescribed in subsection 1, No. 2 might have been completed on seagoing merchant ships with a gross tonnage of 20 or above.

### ***Master on fishing vessels – STCW-F Reg. II/I***

**Section 23.** In order to acquire a certificate of competency as master on fishing vessels, the applicant shall:

- 1) hold a valid certificate of competency as mate 3<sup>rd</sup> class on fishing vessels,
- 2) be a Danish citizen and
- 3) have completed 12 months seagoing service under conditions where a certificate of competency as mate 3<sup>rd</sup> or 4<sup>th</sup> class on fishing vessels, is prescribed.

## **Chapter 3**

### **Certificate of competency as engineer officer on merchant ships and fishing vessels**

**Section 24.** In addition to the requirements for acquiring certificates of competency stated under the individual certificates, the applicant concerned shall:

- 1) be of age and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act and
- 2) hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder,
- 3) have passed the exam or test required for the issue of the certificate of competency within 5 years prior to the date of issue of the certificate of competency, and
- 4) if not otherwise stated, have completed the prescribed engine duty on seagoing fishing- or merchant ships with a propulsion power of 750 kW or above.

### ***Certificates of competency in motor operation***

**Section 25.** In order to acquire a certificate of competency in motor operation, the applicant shall:

- 1) have passed the competency test in motor operation or hold a certificate in engine operation, and
- 2) have completed 6 months seagoing deck service or engine duty on seagoing ships with a propulsion power of 100 kW or above.

### ***Watchkeeping engineer officer – STCW Reg. III/I***

**Section 26.** In order to acquire a certificate of competency as a watchkeeping engineer officer, the person concerned shall:

- 1) have passed the mechanist exam or engineer officer exam,
- 2) have completed 12 months engine duty including an approved training record book.

*Subsection 2.* 6 months of the mentioned engine duty prescribed in subsection 1, No. 2, can be completed in employment ashore.

***Mechanist 2<sup>nd</sup> class – STCW Reg. III/3***

**Section 27.** In order to acquire a certificate of competency as a mechanist 2<sup>nd</sup> class, the person concerned shall:

- 1) have passed the mechanist exam,
- 2) have completed 18 months engine duty, and either hold:
  - a) a certificate of competency as watchkeeping engineer officer, or
  - b) an approved training record book.

*Subsection 2.* 6 months of the mentioned engine duty prescribed in subsection 1, No. 2, can be completed in employment ashore.

***Mechanist 1st class – STCW Reg. III/3***

**Section 28.** In order to acquire a certificate of competency as a mechanist, 1st class, the person concerned shall:

- 1) hold a valid certificate of competency as mechanist 2<sup>nd</sup> class, and
- 2) have completed either 24 months engine duty, 12 months of which in service under conditions where a certificate of competency as mechanist 2<sup>nd</sup> class, is prescribed or have completed 36 months engine duty where a certificate of competency as watchkeeping engineer, is prescribed.

***Engineer officer 1<sup>st</sup> class – STCW Reg. III/2***

**Section 29.** In order to acquire a certificate of competency as an engineer officer 1<sup>st</sup> class, the person concerned shall:

- 1) have passed the engineer officer exam,
- 2) hold a valid certificate of competency as watchkeeping engineer officer, and
- 3) have completed 12 months service under conditions where a certificate of competency as watchkeeping engineer officer is prescribed.

***Chief engineer – STCW Reg. III/2***

**Section 30.** In order to acquire a certificate of competency as chief engineer, the person concerned shall:

- 1) hold a valid certificate of competency as engineer officer 1<sup>st</sup> class, and
- 2) have completed 12 months service as 2<sup>nd</sup> engineer officer, or
- 3) have completed 24 months service under conditions where a certificate of competency as watchkeeping engineer officer, is prescribed.

*Subsection 2.* 12 months of the mentioned seagoing service prescribed in subsection 1, shall have been completed on seagoing ships with a propulsion power of at least 3000 kW.

**Section 31.** The Faroese Maritime Authority may permit that engine duty on vessels which are not merchant or fishing vessels may be partly included in the prescribed engine duty.

**Section 32.** Certificates of competency issued in accordance with sections 25-30 shall entitle the holder to serve on motor ships.

**Section 33.** Certificates of competency issued on the basis of an engineer officer exam may be endorsed to also entitle the holder to serve on steam ships when the person concerned has completed at least 3 months engine duty in steam ships.

## **Chapter 4**

### **On certificate of proficiency and certificates of competency as ships electrician on merchant ships and fishing vessels**

#### *Certificate of proficiency as ships electrician- STCW Reg. 111/7*

**Section 34.** In order to acquire a certificate of proficiency as a ship's electrician the applicant shall:

- 1) be of age and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act and
- 2) hold a health certificate valid for the service for which the certificate of competency entitles the holder,
- 3) hold a course in accordance with the STCW Convention Reg. III/7, and
- 4) have completed 3 months seagoing service on seagoing ships with a propulsion power of 750 kW or above. The seagoing service shall contain service within the electrician profession.

*Subsection 2.* Seafarers who have completed 12 months seagoing service as ships electrician between the period 1 January 2007 and 1 January 2012 on seagoing ships with a propulsion power of 750 kW or above may acquire a certificate of proficiency as a ship's electrician until 31 December 2016.

#### *Certificate of competency as ships electrician- STCW Reg. 111/6*

**Section 35.** In order to acquire a certificate of competency as a ship's electrician the applicant shall:

- 1) be of age, and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act and
- 2) hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder,
- 3) hold a course in accordance with the STCW Convention Reg. III/6, and
- 4) hold a vocational education and training with a certificate of apprenticeship specialized in electrician and

- 5) have completed 30 months engine duty on seagoing ships with a power of 750 kW or above.

*Subsection 2.* Seafarers who comply with the requirements in subsection 1, No. 1-4 and who have completed 12 months seagoing service as electrician between the period 1 January 2007 and 1 January 2012 on seagoing ships with a propulsion power of 750 kW or above, may acquire a certificate of competency as a ship's electrician until 31 December 2016.

## **Chapter 5**

### **On qualification requirements and certificates of proficiency on tankers**

#### *On service on board tankers*

**Section 36.** Officers and able manning on tankers shall have passed the approved course in fire-fighting and the basic training course on tankers, STCW Convention Reg. A-V /1-1.1, and A-V/1-2.1, on Tanker Basic Course.

*Subsection 2.* The provision in subsection 1 does also apply to other seafarers with special tasks and responsibilities in connection with loading operations and cargo-treatment equipment on tankers.

*Subsection 3.* Masters, chief mates, chief engineers, second engineer officers and any other person who, while in service on oil, chemical and gas tankers, is directly responsible for the loading, unloading and control with the cargo shall, in addition to meeting the requirements of subsection 1, hold a certificate of proficiency in the management of operations on tankers, for the type of tanker on which service is performed. The certificate shall be issued by the Faroese Maritime Authority in accordance with STCW Reg. V/1-1.1, and A-V/1-2.1,

*Subsection 4.* Instead of the certificate mentioned in subsection 1, the Faroese Maritime Authority may permit that able manning on board ships registered in the Faroese International Register of Shipping hold foreign certificates in accordance with STCW Reg. V/1-1.1, and A-V/1-2.1.

*Subsection 5.* Instead of the Tanker Basic Course mentioned in subsection 1, the Faroese Maritime Authority may permit that manning who not are officers on board ships registered in the Faroese International Register of Shipping, have acquired foreign certificates drawn up in accordance with STCW Reg. V/1-1.1, and A-V/1-2.1.

#### *On certificates of proficiency on tankers*

**Section 37.** In order to acquire a certificate of proficiency for managing operations on oil, chemical or gas tankers the applicant shall:

- 1) hold a valid certificate of competency as navigation officer or engineer officer,

- 2) have passed an approved special course for the type of tanker for which the certificate is valid within 5 years prior to the date of issue of the certificate of competency, and either
  - a) have completed 3 months service as an officer on board the type of tanker for which the certificate is valid, although service on board on chemical tankers also may be included as service on board oil tankers, or
  - b) have completed 1 months service on board the type of tanker for which the certificate is valid, as a supernumerary officer and, during the service, document at least three loading operations and three unloading operations.

## **Chapter 6**

### **On other certificates of competency and certificates of proficiency**

#### ***Watchkeeping certificate - bridge watch duty STCW Reg. II/4***

**Section 38.** In order to acquire a watchkeeping certificate for bridge watch duty, the applicant shall be 16 years of age and shall hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder, including be fit for lookout duty, and either:

- 1) have passed the basic training module for ship's assistants, the ship's assistant training programme for persons holding a certificate of apprenticeship specialized in machinery, electrician or other relevant vocational education and training or have completed the basic training module for maritime practical training, and have completed 2 months seagoing deck service on seagoing ships of gross tonnage of 20 or above, and in this period, under the supervision of the watchkeeping navigating officer, is instructed according to the provisions stipulated in executive order on watchkeeping on ships, or
- 2) have completed 6 months seagoing deck service duty on seagoing ships with a gross tonnage of 20 or above, and in this period, under the supervision of the watchkeeping navigating officer, is instructed according to the provisions stipulated in executive order on watchkeeping on ships.

#### ***Watchkeeping certificate – engine duty STCW Reg. III/4***

**Section 39.** In order to acquire a watchkeeping certificate for engine duty, the applicant shall be 16 years of age and shall hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder, and either:

- 1) have passed the basic training module for ship's assistants, and have completed 2 months engine duty on seagoing ships with a propulsion power of 750 kW or above, and in this period, under the supervision of the watchkeeping engineer officer, is

instructed according to the provisions stipulated in executive order on watchkeeping on ships , or

- 2) have completed 6 months engine duty on seagoing ships with a propulsion power of 750 kW or above and in this period, under the supervision of the watchkeeping engineer officer, is instructed according to the provisions stipulated in executive order on watchkeeping on ships.

### *Certificate of competency as radio operator*

**Section 40.** In order to acquire a certificate of competency as radio operator the applicant shall:

- 1) be of age and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act and
- 2) hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder, and either hold:
  - a) a limited certificate as a radio operator in GMDSS, ROC in accordance with STCW Reg. IV/2, or
  - b) have passed the test for radio operators in GMDSS, GOC, in accordance with the STCW Convention Reg. IV/2, within 5 years prior to the date of issue of the certificate of competency.

### *Certificate of competency as a ship's cook*

**Section 41.** In order to acquire a certificate of competency as a ship's cook on merchant ships, the applicant shall be 18 years of age, and hold a certificate of apprenticeship within cook specialization.

*Subsection 2.* In order to acquire a certificate of competency as a ship's cook on fishing vessels, the applicant shall be 18 years of age, and shall have completed training as a gastronomy assistant.

*Subsection 3.* <sup>1)</sup> In order to acquire a certificate of competency as a ship's cook on fishing vessels engaged on near local voyages, the applicant shall be 18 years of age, and shall at least have completed certificate training programme pursuant to section 1 in Executive Order on the hygienic competences of seafarers handling of articles of food on board ships. A ship's cook who holds a certificate of competency pursuant to clause 1 may, with permission from the Faroese Maritime Authority, sign on a vessel which is usually engaged on near coastal voyages, when the vessel, in special cases, is engaged in commercial fishing outside Faroese territorial waters.

*Subsection 4* <sup>1)</sup>. Seafarers who have acquired a certificate of competency as a ship's cook issued before this executive order enters into force retain their validity.

## **Chapter 7**

### **Basic safety training and – instruction for all seafarers**

### ***Merchant ships***

**Section 42.** Before being assigned to any shipboard duties on board merchant ships, the master shall ensure that all employed seafarers on board, receive training in personal survival techniques and receive appropriate information and instructions in accordance with the STCW Convention Reg. VI/I and A-VI/I section 1 on “Familiarization Training” in such a way that the seafarers are able to:

- 1) communicate with other seafarers on board on basic safety matters and understand safety symbols, signs and alarm signals and
- 2) know what to do if:
  - a) a person falls overboard,
  - b) if smoke or fire is detected or
  - c) if the fire alarm or abandon-ship alarm sounds,
- 3) can identify stations for muster and embarkation, emergency-escape routes,
- 4) can locate and don life-jackets,
- 5) can raise the alarm, knows the use of portable fire extinguishers,
- 6) can take immediate action upon encountering an accident or other medical emergency before seeking further medical assistance on board,
- 7) can close and open fire doors, weather-tight doors and watertight doors fitted in the vessel other than those for hull openings, and
- 8) handle waste on board the vessel in order to avoid environmental pollution.

**Section 43.** Seafarers on merchant ships who in accordance with the Minimum Safe Manning Document are required for duty on board, besides other seafarers who have special tasks in connection with safety and prevention of the environment, shall have passed an approved basic safety training course for seafarers in accordance with the STCW Convention Reg. VI/I and A-VI/I, section 2 on “Basic Training”.

*Subsection 2.* Foreign basic safety training courses meet the requirements in subsection 1, if the certificate is issued by an approved authority in a country that complies with the regulations of the STCW Convention.

*Subsection 3.* After 31 December 2016, all officers shall hold an advanced fire fighting certificate according to STCW Reg. VI/3.

### ***Fishing vessels***

**Section 44.** Persons who sign on fishing vessels shall hold a valid basic safety training course for seafarers- in accordance with the STCW Convention Reg. VI/I and A-VI/I, section 2 “Basic Training”. Foreign basic safety training courses meet the requirements in item 1, if the certificate is issued by an approved authority in a country that complies with the regulations of the STCW Convention.

*Subsection 2.* On fishing vessels where self-contained breathing apparatus is not a requirement, seafarers may be exempted from the requirement on smoke diving according to



the STCW Convention Reg. A-VI/1-2. Moreover, seafarers who are not obliged to smoke dive according to the muster list, may be exempted from the requirement on smoke diving according to the STCW Convention Reg. A-VI/1-2.

***Revalidation of the basic safety training courses and the advanced fire fighting courses***

**Section 45.** The certificate on passed basic safety training course according to the STCW Convention Reg. VI/I and A-VI/I, paragraph 2 on Basic Training subsection 1 shall be revalidated every fifth year.

**Section 46.** The certificate on passed advanced fire fighting course according to STCW Reg. VI/3 shall be revalidated every fifth year.

***Certificate of competency in using safety equipment***

***Survival craft and rescue boats***

**Section 47.** In order to acquire a certificate of competency in using survival crafts and rescue boats, except for fast rescue boats, the applicant:

- 1) shall be of age, and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act and
- 2) shall hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder,
- 3) shall no more than 5 years prior to the date of issue of the certificate of competency, have passed an approved course in survival crafts and rescue boats, except for fast rescue boats, according to STCW Reg. VI/2, paragraph 1, and shall
- 4) have completed 6 months seagoing service on seagoing ships with a gross tonnage of 20 or above.

***Fast rescue boats***

**Section 48.** In order to acquire a certificate of competency in fast rescue boats, the applicant:

- 1) shall be of age, and not subject to guardianship according to section 5 of the Guardianship Act or to special guardianship according to section 7 of the Guardianship Act and
- 2) shall hold a health certificate for seafarers valid for the service for which the certificate of competency entitles the holder, and
- 3) shall hold a certificate of competency in fast rescue boats in accordance with section 47 and shall

- 4) no more than 5 years prior to the date of issue of the certificate of competency, have passed an approved course with a satisfactory result in fast rescue boats, according to STCW Reg. VI/2, paragraph 2.

## **Chapter 8**

### **General provisions**

#### *Responsibilities of the shipowner and the master*

**Section 49.** The shipowner and the master shall ensure that the seafarers serving on board meet all the training, qualification and certificate of competency requirements prescribed for the position concerned and that the prescribed original certificates are available on board.

#### *On seagoing service for acquiring certificates of competency*

**Section 50.** Seagoing service means service on board vessels which give seafarers the relevant knowledge, insight and competency or maintenance of competencies for acquiring a certificate of competency.

*Subsection 2.* The seagoing service will be documented with a copy of the discharge book. Under certain circumstances, the Faroese Maritime Authority may permit that the shipowner in question confirms the seagoing service in writing.

*Subsection 3.* The Faroese Maritime Authority may equate other practical experiences with completed seagoing service, if these experiences are considered to be of relevance for the seagoing service required. Other practical experiences shall be confirmed in writing from the employer.

*Subsection 4.* When this executive order requires seagoing service to be completed, the seagoing service shall have been legally acquired. This means that the applicant has acquired the seagoing service by holding a valid certificate of competency, the basic safety training course, health certificate etc. required for the position for which the applicant has signed on.

*Subsection 5.* When this executive order requires seagoing service to be completed in a position for which a specific certificate of competency is prescribed, seagoing service completed in a corresponding position on foreign or Faroese ships may be included, notwithstanding the name of the prescribed certificate of competency.

*Subsection 6.* Seagoing service on vessels without main propulsion machinery may only be included when the certificate of competency is to be revalidated.

#### *Issue of certificates of competency and their validity*

**Section 51.** The Faroese Maritime Authority issues certificates of competency, including certificates of proficiency. The certificates are issued in a format authorised by the Faroese Maritime Authority, cf, however, subsection 4.

*Subsection 2.* Certificates of competency and certificates issued in accordance with sections 8-15, sections 19-23, sections 25-30, section 37, section 40, section 47 and section 48 are issued with a validity of 5 years from the date of issue.

*Subsection 3.* Certificates of competency may be renewed 6 months before the expiry of an existing certificate of competency, at the earliest.

*Subsection 4.* The Faroese Maritime Authority may authorize other persons or institutions to issue certificates of competency and certificates of proficiency according to sections 4-6, section 47 and section 48.

*Subsection 5.* Masters and navigation officers on merchant ships shall comply with the specific educational requirements stipulated in appendix 1.

*Subsection 6.* After 31 December 2016, masters and navigation officers and engineer officers on merchant ships shall comply with the specific educational requirements stipulated in appendix 2.

### ***Exemptions***

**Section 52.** If the passed exam is older than 5 years when the person concerned applies for his first certificate of competency, the certificate may be issued, on the condition that the person concerned passes tests or completes courses required by the Ministry of education, research and culture, with regard to the year of examination and subsequent employment of the person concerned.

**Section 53.** The Faroese Maritime Authority may, under special circumstances, allow the issue of a certificate of competency, with limited rights if relevant, notwithstanding that the requirements laid down for acquisition of the certificate of competency concerned have not been fully met. Exemptions from meeting requirements for exams and seagoing service may, however, only be granted if the person concerned has acquired adequate theoretical and practical training in some other manner.

*Subsection 2.* The Faroese Maritime Authority may, under special circumstances, allow a person to carry out continued service in a position for which a certificate of competency is not required, notwithstanding that the person concerned does not fully meet the requirements laid down for signing on in the position. Such a permit may, however, only be granted if the Faroese Maritime Authority assesses that the safety in its entirety does not deteriorate for that reason. Such a permit may, however, only be granted, if the person concerned documents having acquired the actual competencies and education, required for service in the position.

*Subsection 3.* The permit according to subsection 1 may on the same condition be granted for certificates of proficiency in accordance with sections 4-6, however, only until 31 December 2016.

### ***Revalidation of certificates of competency – STCW and STCW-F***

**Section 54.** In order to revalidate a certificate of competency and a tanker certificate at management level, the applicant is required to hold a health certificate valid for the service

for which the certificate of competency or certificate of proficiency entitles the holder, and either have:

- 1) completed 1 year seagoing service on seagoing ships as navigation officer, engineer officer, or radio operator, respectively, during the last 5 years,
- 2) completed 3 months seagoing service on seagoing ships as navigation officer, engineer officer, or radio operator, respectively, during the last 6 months,
- 3) carried out work related to the applicant's certificate of competency, and which the Faroese Maritime Authority may approve as being equivalent to the required service mentioned in No. 1.
- 4) passed tests or completed courses required by the Ministry of education, research and culture, with regard to the year of examination, seagoing service and the last signing on of the person concerned, or
- 5) completed 3 months seagoing service on seagoing ships as navigation officer or engineer officer, respectively, in a lower ranking position for the last 6 months, if the certificate of competency has expired.

*Subsection 2.* In addition to the requirements of subsection 1, the applicant shall after 31 December 2016, be able to document to have maintained the competencies in safety according to STCW Reg. VI/I, and A-VI/I, paragraph 1-4 the on Basic Training.

*Subsection 3.* In order to have a tanker certificate at management level revalidated, the applicant shall have completed 3 months seagoing service during the last 5 years in tankers of the type for which the certificate of competency entitles the holder. However, seagoing service completed on chemical tankers may be included as seagoing service on oil tankers.

*Subsection 4.* In order to revalidate a certificate of competency as radio operator in GMDSS, GOC, the seagoing service as navigation officer is approved as being equivalent to seagoing service as radio operator. The seagoing service shall be completed on vessels with the radio equipment which is required for revalidation of GMDSS, GOC, according to executive order that the Faroese Maritime Authority carries out certain tasks on behalf of the National Telecom agency.

### ***Penalty***

**Section 55.** The shipowners or master's violation of sections 42 and 49 shall be punishable by a fine.

*Subsection 2.* Companies, etc.(legal persons) may incur criminal liability pursuant to the provisions of chapter 5 of the penal code.

*Subsection 3.* When determining criminal liability pursuant to subsection 2, persons employed to carry out work on board the ship by others than the shipowner shall also be considered as being associated with the shipowner. If a document of compliance has been issued pursuant to the International Safety Management Code or a certificate has been issued

pursuant to the Maritime Labour Convention to another organisation or person, the master of the vessel as well as the seafarers shall be considered to be associated with the one to whom the document has been issued.

## **Chapter 9**

### **Entry into force and transitional provisions**

#### *Entry into force*

**Section 56.** This executive order comes into force the day after it has been promulgated. However, section 41 comes into force 1 January 2017.

*Subsection 2.* At the same time as this executive order enters into force, executive order No.20 of 22 April 2010 on certificates of competency and qualification requirements to manning on ships, is made void. However, section 34 is made void 1 January 2017.

#### *Transitional provisions*

**Section 57.** Certificates of competency and certificates of proficiency issued according to executive order No. 20 of 22 April 2010 certificates of competency and on qualification requirements to manning on ships, shall remain in force in accordance with the date of expiry given on the certificate of competency.

*Subsection 2.* Seafarers who are subject to section 16 subsection 1, No. 2 and section 17 subsection1 No. 2 may sign on even if the requirement on the safety basic course has not been met.
